We continued to refine our Online and Mobile Banking systems, with enhancements such as the re-introduction of free FICO® Scores. We focused on the service levels provided by our Contact Center, with our average speed-to-answer decreasing from over two minutes to less than thirty seconds. While I'm proud of our accomplishments this past year, there's much work to do in 2020. We will continue to focus on improving service levels, and making it easier to do business with us. We're entering the final phase of improvements and modernization to our internal systems, by which I mean those utilized by our employees (as opposed to member-facing systems such as Online and Mobile Banking). This modernization of internal systems will enable and empower our employees to provide members better service, both in speed and accuracy, in the coming year and beyond.

I'm excited for the coming year, and what it has in store for our members and staff alike.

The Seal


